What can really only be portrayed as the most bizarre session capped off with an even more unusual conclusion that I have seen during my tenure as a lobbyist; it left most legislation stranded.

The Session began with the most unfortunate news of Auditor Schweich's death, followed 5 weeks later by his chief political advisors death. The State budget took more twists and turns than I can recall in recent years, the senate using a procedural motion that has not been invoked for 8 years to pass Right to Work and then a Speaker resigning from his post and house seat on the final day of session.

To put this in perspective, the last 6 days of legislative session is when the Senate passes 70% of all the non-budget bills for the year. That would account for approximately 120 bills, which each contains several issues per bill. This year, the final 6 legislative days saw 2 bills cross the finish line, both of which were single subject and not omnibus bills.

All of this to say, passing legislation was nearly impossible.

The Budget was finally completed, which included a \$300,000 increase for firefighter training in FY16. This came just days after the Governor released the additional \$200,000 appropriated for the current fiscal year (FY15). That will be just in time to get classes into the field before the fiscal year concludes on June 30<sup>th</sup>.

## 911 Bill Blocked by Senate

The 911 bill made it further than it has moved in year's past, BUT it did not clear what we all knew was the highest hurdle; the Senate. The Chairman of the Senate Local Government Committee kicked off the Senate bashing parade against this item as it included a tax increase, which is the plague for those sitting legislators running for higher office. Senator Schmitt is running for State Treasurer. He was not alone in his opposition to the bill, as others want more consolidation prior to more money being spent on the 911 system. They believe this is the best opportunity for reform to the system.

Rep Lauer did a great job promoting the bill, but the Senate continues to be a hurdle we can not clear until their "consolidation" issue is satisfied.

#### **FPD** Consolidation

A consolidation/merger amendment was passed this week. It fixes an annexation issue in North St. Louis County, yes St. Louis County. After re-reviewing the language the proponents decided it did not fix their issue, and wanted it removed. This language would have allowed select fire districts in St. Louis County which have had cities annex a portion of their district to directly bill those property owners for property taxes in lieu of the cities, which in turn currently pay the district a lump sum. This bill did not make it through due to internal disputes among the proponents as well as the meltdown I noted in the opening paragraph.

#### **Board Member Employment Restriction**

A bill, which precludes FPD board members to be employed by the district within one year of retiring from the board, made progress, but in the end stalled.

#### **Medicaid ER Diversion Fails**

HB 795 Hinson(R) - Specifies that EMT's who divert MO HealthNet recipients who do not require emergency treatment from emergency departments to other facilities shall be eligible for an additional reimbursement. This bill simply allows Medicaid to pay for those services already allowed. This does not change the current protocol required. The bill initially received opposition, but once it was better defined, opposition was dropped. It did not pass.

**Ambulance FRA Extension** passed in the final minute of session prior to the Senate adjourning for the year. It was the Senate's last order of business. The bill extends the collection of the FRA for another year, which is the mechanism that funds the payments to Medicaid ambulance service providers.

#### LOD Death Benefit Fails to Pass

HB 33 Walker(R) Adds emergency medical technicians to the list of public safety officers eligible for survivor's and disabled employee's educational grant program. We amended onto this bill our fix for the LOD benefit, which will allow spouses or children to apply for the LOD death benefit instead of only the estate of the deceased. The bill also included DPS officers.

This bill has broad support, but was another victim of the last week of session antics.

## **LAGERS** Fails

Allows political subdivisions to elect to cover firefighters, EMT and other law enforcement personnel as members of the Missouri local government employees' retirement system (LR# 1571H.01I) This bill will not affect districts from adjusting their levy amounts as long as the levy remains below the voter approved levy rate.

## **Property Tax Cap Remains Fails**

Representative Hinson and Senator Schatz each filed a bill to prevent taxing jurisdictions from assessing a levy higher than that approved by the voter. It is debatable whether this bill affects FPD, since I have not yet heard of a FPD attempting to impose such a levy rate. This bill warranted a lot of discussion and the sponsors were very good with which to work to resolve any unintended consequences. The bills were not pursued by the sponsors in the end.

HB 275 Hinson(R) Modifies provisions relating to tax rates.

SB 223 Schatz(R) Eliminates a provision allowing for property tax levy adjustments for inflation and modifies standing for Hancock Amendment challenges

## **EMT Liability Protection Stalled in Senate Committee**

Rep Shaun Rhoads, Chairman of Public Safety Committee, passed HB868, which relates to EMS issues, and amended the bill with the EMT liability protections we support. This bill inserted EMT's into the statute which grants liability protection to other health care practitioners when transporting a mental health or drug or alcohol patient contrary to the patient's wishes for an involuntary temporary commitment when authorized by a mental health coordinator.

He also included a revision to the **96 hour hold** rule to ensure it begins when the patient enters the ambulance so the EMS crew can legally restrain the patient if necessary.

This bill has several topics including changes to the **TIF Special Allocation Fund**, **Critical Time Diagnosis, and Disciplinary Action of an EMT and terms of Regional EMS Directors. The Community Paramedic provision was removed from the bill at the request of Representative Hinson.** The bill likely would not have made it across the finish line, but was held by Senator Eric Schmitt in committee until the final 10 days of session. I am unclear of which portion of the bill he opposed.

HB 868 Rhoads(R) Modifies provisions related to emergency medical services.

## Public Safety Sales Taxes

Three proposals were introduced in the House, which would have allowed cities to submit to the voters a public safety sales tax up to .5%. Liberty and North Kansas City both had specific authorization requests and Representative Charlie Davis filed a bill to allow any city the authority. Liberty and NKC progressed well on several bills, but Rep Davis' bill stalled as the legislature is very sensitive to additional sales tax authority for local jurisdictions. They all failed in the end, although the NKC and Liberty have support but were caught in the end of session black hole.

## Filing Fee Bill Fails

The bill to fix the \$50 filing fee for FPD director elections stalled as the session came to an end.

#### **Direct Payment to Patient**

We continued to watch for any movement by BCBS to introduce language to require insurers to pay patients for claims by providers that are out of network. That is a logistical nightmare for fire agencies that run ambulance services. This would require you to collect from the patient the money they received from BCBS. Who knows how the patient would allocate those funds. A new cell phone maybe?? Nevertheless, this issue never materialized.

Related to this issue is a bill filed in the senate relating to Out of Network Medicaid Services. SB243, sponsored by Senator Schmitt, would require Medicaid managed care companies to meet an 85% medical loss ratio (MLR), similar to that of private insurance; BUT the bill does not require a full refund of the amount they were short of the MLR. Second, the bill states;

"For services that do not meet the definition of emergency services, a Medicaid managed care organization shall be required to reimburse out of network providers at the published MO HealthNet Medicaid fee-for- service schedule at the time of the service. A Medicaid managed care organization shall document three good faith attempts to include the provider in their network, using their standard participating provider agreement and fee schedule. "

This would have been a big problem for ambulance service providers with any level of Medicaid transports. We opposed this measure, which never made progress.

#### Local Fire Inspection Elimination Stalled

HB 897 Hubrecht(R) would have eliminated local fire inspections of long term care facilities, and placed the duty with the Fire Marshal's office. The committee modified the bill after our objections, and instead added language that required local and state inspectors to coordinate timing of the inspections so they can occur on the same day as much as practicable. Despite that being a reasonable solution, the bill did not pass.
